First Vice Chair Knapp moved to approve the minutes for March 21 closed and open sessions; Trustee Levine seconded. The minutes were unanimously approved by the Board.

### 6. REPORTS

# A. President's Report

Dr. Pollard provided comments on the AACC Convention that was held April 9–12 in Chicago and reported that the College was named the "Outstanding College/Corporate Partnership Award of Excellence" winner. She thanked everyone who helped to make this happen.

Dr. Pollard provided an update on the FY17 budget at the state and local levels. She thanked everyone who attended and provided testimonies at public hearings on the budget earlier this month.

The president provided her monthly report and a brief video on the theme of guided pathways. As related to the book, *Redesigning America's Community Colleges: A Clearer Path to Student Success*, she shared information about the transfer process at Montgomery College. Dr. Pollard reported that 60 percent of MC students are enrolled in a curriculum intended to prepare for transfer and each year a significant number of them transfer to institutions inside and out of Maryland. She noted that one-fourth of MC students transfer within three years of beginning at the College. Dr. Pollard provided remarks on how credits are transferred from community colleges to four-year institutions. She noted that the transfer process can make or break a student's progress to a degree. Dr. Pollard cited the guidance and tools that students receive at the College that make the transfer process easier and more comprehensive than it has been in the past.

Trustees' comments focused on the general studies degree and transferring to the Universities at Shady Grove.

### B. Chair's Report

Chair Smith provided comments on the appreciation dinner held earlier in the evening with the Montgomery College Foundation, the Life Sciences Park Foundation, and the Alumni Board of Governors, thanked the Trustees for their advocacy efforts this month, thanked Dr. Pollard for an outstanding State of the College address, and congratulated the College on winning the AACC award. Chair Smith thanked the Trustees, the campus vice presidents and provosts, their staff, faculty, and students, and members of the boards of the supporting organizations for participating in Trustee Information Day held on April 4.

Chair Smith invited Trustees to report on committee meetings and activities for the month.

Trustee Levey commented on his visit to Leisure World; Trustee Aparicio Blackwell commented on her meetings with councilmembers and the opportunity to showcase the work of the College. Trustee Levine provided comments on his professional development opportunity at the AACC Convention, and Trustee Hoffman provided comments on his visit to the Rockville Campus

during Trustee Information Day.

Dr. Pollard explained the uses of the transportation fee and noted that the state does not fund parking structures. She explained that the transportation fee is also used to pay the debt service for bonds, and that the College is not allowed to borrow against them.

Trustee Hydorn noted that the College was not the only institution involved in this situation as
