Trustee Hydorn moved to approve the minutes for April 18 and 25, 2016, closed and open sessions; Trustee Hoffman seconded. The minutes were unanimously approved by the Board.

6. REPORTS

A. President's Report

Dr. Pollard provided comments on the death of Mr. Malcom "Mike" Winffel, the spouse of a College employee, who was tragically killed in the Westfield Montgomery Mall incident last week, and asked for a moment of silence to remember him.

Dr. Pollard provided brief remarks on the upcoming commencement ceremony as well as a budget update.

Dr. Pollard provided a final report on guided pathways. As related to the book, *Redesigning America's Community Colleges: A Clearer Path to Student Success*, she took a look at how the College creates pathways to employment for students. She noted that, with the wide breadth of degrees and certifications that the College offers, each pathway can look quite different, but all students have access to the same valuable tools and services to aid in their job searches. For example, she said, there is an extensive Career Services program, an online Career Coach program, and a Cooperative Education and Internship Program, which help students decide what field they want to enter and how to make the right connections to employment. Practicums and internships are offered, and students who pass the right exam for licensure are frequently hired quickly.

Dr. Pollard shared a brief video on pathways to employment through Montgomery College.

Trustees' comments focused on the College obtaining information from students who are not at the institution for credit courses, career coaching, education with a purpose, course sequences, and connecting with employers.

B. Chair's Report

Chair Smith provided comments on the conference session held earlier in the evening on commencement, the budget update, and the bargaining agreements. She noted that the Board wanted to express profuse gratitude to AFSCME for settling its full collective bargaining agreement, and to AAUP and SEIU for returning to the bargaining table to reopen their contracts on the limited wage issue for FY17.

Chair Smith highlighted the May 3 conference session on the Middle States reaccreditation process that was held with Dr. Sean McKitrick and invited Trustees to view the recorded session if they were not present.

Chair Smith invited Trustees to report on committee meetings and activities for the month.

Trustee Levey reported that he had spoken to county councilmembers about the bus depot matter that is proposed to be located in the MCPS parking lot across from the College's Mannakee Building.

Trustee Hydorn reported that he attended the honors convocation at the Germantown Campus as well as the graduation ceremony at the Universities at Shady Grove and had a tour of the facilities. He met with the county council today on the budget along with Chair Smith and Dr. Pollard, attended the Alumni Association fundraiser and thanked everyone for coming out to help raise \$7,500 for scholarships.

Trustee Hoffman commented on the bus depot matter and housing plans for the community.

Trustee Priddy reported that he attended the Hillman Entrepreneurs Program ceremony and heard four great student presentations.
