- There is consensus that we are on the road we want to continue going down. Can we have an anti-racism strategy that lifts all groups?
- Seek to articulate a statement of why we are going down this road.
- Commit to enhanced conversations within the College and the multiple communities and relationships of which we are a part.

The Board's Executive Committee will review this list and develop a direction to move forward.
