Course Description:

Powers, organization, and functions of state and local governments; case studies. Emphasis on the governments of the state of Maryland and of Montgomery County.

Credits, Hours, Prerequisites:

A.Three (3) Semester Hours Credit.

B.Three (3) Class Hours Per Week; Zero (0) Laboratory Hours Per Week.

C. Prerequisite: EN 101/EN 101A

Student Outcomes:

Upon completion of this course, the student will be able to:

- 1. Describe and explain state and local governments' structure, functions, problems, and their impact on residents in the USA.
- 2. Recognize and analyze the unique nature of politics and government in Maryland and Montgomery County.
- 3. Apply skills and concepts to work with decision makers (elected and appointed state and local government).
- 4. Demonstrate an understanding of how to lobby state and local official effectively to bring about change.
- 5. Describe and explain the challenges facing Maryland and Montgomery County in the current year and beyond and relate those factors to his or her daily life.

Evaluation:

A student's final grade in this course will be determined as follows:

- 70% **Two Examinations** (35% each) based upon textbook, reserve readings, class lectures, & class discussions. Both exams may consist of any & all of the following formats multiple choice, short identification, & essays. The final exam is not cumulative.
- 30% There will be three Miscellaneous Assignments which will count collectively as 30% of your overall final grade. Each of these assignments will include a written component & potentially some multiple choice questions, but will also involve critical thinking, the text, & outside sources. While there may be some alteration to this schedule, please expect these assignments to include some extra credit possibilities as well.
